15172 Community Mini Bus update

The grant from NWLDC will be passed direct to Measham Mobility, the Parish Council will remain a 'sleeping partner' – Deana Wildgoose has kindly offered to continue as a volunteer with this project. The application to Awards for All has been cancelled as the funding is not required yet – when the mini bus has been purchased then further funding can be identified as required.

15173 Sir John Moore Foundation update

- 1) The gallery element of the Stables works will be completed by Christmas. There will be a variation to the original planning permission and a new LBC (can't vary a lbc) so these will come through to the Parish, only a few minor things.
- 2) Social Tuesday going really well. It's getting too big for the existing room so desperately need the new one. (They meet every other Tuesday 2-4 with support from Carla from Saffron and Gillian Day.) About 16 came last week from all over Appleby, mainly older people.
- 3) Re 20forSeven NWLDC grant application have gone for a collaboration with primary schools on developing resources and activities with primary school kids based on heritage heroes; the science of heritage and British Values. It will be like the mad scientist meets horrible histories, and be accessible to all. Applied for a £20k contribution to a £40k project. Have included some on site resources including a scent cinema. The activities and resources need to benefit a wider community than just the schools in school time.
- **15174 Village Design Statement & Neighbourhood Plan** keep on agenda, both discussed, but agreed to defer to future meeting.

- a. New 3D village sign this should incorporate Appleby Parva defer to February 2016.

- f. Community Tuesday Club the Clerk to request further information and ask Carla to attend the next PC meeting.
