1569 Planning Consultations

a. 15/00409/FUL, Land opposite 39 Bowleys Lane, erection of detached garage with loft above – no comment.

1571 Allotment Matters

a. Cllr Smith reported that the gate has been repaired and a site clean-up has taken place. There are 5 new members – the local Tesco store will hold brochures for public use. The Allotment Society is looking into grants for refurbishment works and the group plan to have their own orchard on site.

1572 Footpaths, Hedgerows & Street Matters

- a. Cllr Smith reported that he is still looking into ways of preventing vehicles from parking along Rectory Lane verges.
- b. Play equipment for the recreation field play area was discussed Cllrs Bird and Whitehurst to investigate further and report back.
- c. Allotment field tenancy update Clerk to ask Mr Ian Hamilton for an update re the lease.
- d. Cllr Hemmerdinger reported that he had obtained quotes for replacement and installation of kissing gates 14 need either repair or replacement. All agreed that Cllrs Hemmerdinger and Bird conduct a tour of the village kissing gates and prioritise repair/replacement; also to review the best type of gate for each area. Cllr Hemmerdinger to obtain a quote for installation only.
- e. A new 3D village sign was discussed, the Clerk provided details we need to put together a 'picture' of what the sign will look like defer to June 2015 meeting.
- f. NWLDC play area inspection report nil to report, noted.
- g. Village green to be listed as a Community Asset following investigation and advice/information from NWLDC it was decided to close this matter.
- h. A letter had been received re sponsorship for AMCC (Appleby Magna Cricket Club) the Parish Council is not in a position to offer commercial sponsorship, but advised that S137 funding may be requested via the formal procedure.

1573 Approval of Financial Statements & Payments

- a. The payment list and bank reconciliation were reviewed and approved, **RESOLVED**, unanimous.
- b. Members had received a copy of the end of year bank reconciliation and associated documents, these were approved, **RESOLVED**, unanimous.
- c. Members approved the annual financial report from the Internal Auditor, **RESOLVED**, unanimous.
- d. Members reviewed and approved the annual return, signed by the Chairman and Clerk, **RESOLVED**, unanimous.
- e. The annual insurance quote had been received from the current insurers, Aon, other quotes had been received, but as they were higher, it was proposed to accept the Aon quote which is the same as last year no increase **RESOLVED**, unanimous.
- f. The final budget against actual figures had been reviewed and approved, **RESOLVED** unanimous.
- g. Members noted the Notice of appointment of date for the examination of electors has been posted on notice boards as per legislation.
- h. AMCC (Appleby Magna Cricket Club) and the Parish Council had discussed which was the best option to have the recreation ground maintained by an outside contractor, or for AMCC to ensure the ground is maintained to a satisfactory level, with the Parish Council continuing to contribute to costs. Cllr Hemmerdinger proposed, seconded by Cllr Smith, it was **RESOLVED** unanimous to pay £700 to AMCC for 2014 costs and from 2015 pay £1,000 per annum towards costs, to be reviewed on an annual basis. Clerk to ask Mr Ian Hamilton to assist with the production of a new lease for the Parish Council/AMCC and a new constitution for the Appleby Sports & Recreation Club.
